The LLC Operating Agreement form download explains and defines the company structure, rights, responsibilities and duties of its members; this can be used to circumvent State rules under the LLC Act. The LLC can be either a single member or a multi-member. In the instance of being a multi-member LLC this agreement acts in a similar way to a partnership.

There are two types of LLC Agreement, (a) Member Managed and (b) Manager Managed.
