In this situation the original tenant retains some responsibilities to the Landlord for all issues: property maintenance, payment of rent and all original liabilities and obligations as security of tenure to the landlord until the original lease agreement has expired.

Sub-Lease Agreement

The sublease agreement is a contract which conveys some or all of the property rights that a tenant has under a residential lease to a third party for a portion of the tenant's remaining term of the original lease or for a portion of the space leased under that lease.

Under the sublease agreement form the original tenant assumes the responsibility of the landlord to the new tenant.
